Civil Paper Service Leads to an Arrest

When a Deputy attempted to serve civil papers in the 55000 block of US Hwy 285 in Shawnee on 02/08/18 a party was found to have a warrant for Failure to Appear in the Park County Combined Court and was taken into custody and transported to the Park County Jail.

DUI Arrest

On 02/08/18 a Patrol Sergeant initiated a traffic stop in the 500 block of Castello in Fairplay for 10 mph over the posted speed limit. The driver was found to have a revoked driver's license for a previous DUI and the Sergeant detected the presence of an unknown alcoholic beverage. The party refused Standard Field Sobriety Tests and was arrested for Driving Under Revocation and suspicion of DUI and transported to the Park County Jail. The party had been arrested by the same Sergeant six months previously for the same offense.

Traffic Citation at Traffic Court

On 02/06/18 a party arrived at Park County Combined Court for a Court Trial for the charge of Driving Under Restraint. The party drove to court from Denver with a Provisional Driver's License and was issued a fresh citation for Violations of Provisions on a Driver's License.

Warrant Arrest

In the 58000 block of US Hwy 285 a knock and talk resulted in the arrest of a party for two outstanding Park County warrants for Contempt of Court and Failure to Appear. She was transported to the Park County jail.

Abandoned Vehicle Leads to an Arrest

On 02/04/18 a Deputy came upon an abandoned vehicle blocking Saddlestring Road in Bailey. Various parties were contacted and a citation was issued for Operating an Uninsured Motor Vehicle and the party was advised to tow the vehicle and not to drive it. The party acknowledged this directive.

Twenty minutes later the Deputy observed the party driving the car and initiated a traffic stop on Royal Ridge Road. Upon arrest for Operating an Uninsured Motor Vehicle the party was found to have an alleged methamphetamine pipe in his pocket and was additionally charged with Possession of a Controlled Substance. The party was transported to the Park County Jail.

Domestic Violence Arrest

A female party reported an incident on 02/04/18 of alleged domestic violence that occurred the previous night to Deputies in the Bailey area.

The male party also told the female party that "if the police came, that he'd shoot or kill them". A warrant was obtained for the "cold" Domestic Violence and False Imprisonment the male party was arrested in the course of a traffic stop on 02/06/18.

A second warrant was obtained for Possession of a Dangerous/Illegal Weapon due to the home-made silencer/suppressor for a rifle that was located in the residence. The male party was transported to the Park County jail.

Rolling Argument

Park County Communications received a call on 02/03/18 of a "rolling dispute" on Cr. 43. Deputies contacted the two vehicles in the parking lot of Derrick Thai. The dispute stemmed from a pending divorce and the parties were separated and the issue of the ownership of the vehicles was explained to be a civil matter and to be handled in court.

Stalking Arrest

On 02/02/18 a suspect with a warrant for Stalking/Harassment and Intimidating a Witness was contacted in the parking of the Bailey Substation and was transported to the Park County Jail.
