## CHORE PROGRAM EXPLANATION & FORM

### Chore Program

The Park County Senior Coalition's Chore Program is funded by the state of Colorado through Pike's Peak Area Council of Governments. This funding places certain criteria on the projects which the Coalition can undertake. Chore clients must be at least 60 years of age. There must be an evident need for the project, and the project must be health and safety related. Park County Senior Coalition assists with materials, and does not provide labor. \* PLEASE NOTE: The Chore Program is not an emergency service. Some lead time is involved, and could take several weeks.

### Requesting Chore Assistance

1. You must be signed up as a Park County Senior Coalition client to receive service.
2. The home must be the primary residence.
3. You must attach a *vendor's* estimate breaking down the cost of materials and labor, and stating hours of labor.
4. This is not a reimbursement program. Do not buy anything. The Coalition will make the check payable to the vendor once the project is approved, and send the check to you to forward.

### Acceptable Projects

Minor home health and safety renovations, alterations, and/or restorations to include: grab bars, ramps, replacing weak floor boards on a porch or deck, plumbing, electrical, furnace, etc."

### Home Services Donation

**There is NO CHARGE for the Park County Senior Coalition's Chore Services.** Donations are requested, but not required. Our funders require we ask all clients for a donation. Coalition policy for Chore Services states the recommended donation is equal to 10 percent of the estimated project value. All Chore Services Donations are placed back into the budget for the program. Park County Senior Coalition is a 501 © (3) non-profit corporation. Your donations are tax deductible.
